



**INVITATION TO BID
FOR THE SUPPLY AND DELIVERY OF
ONE (1) UNIT MOTOR VEHICLE**

1. The Housing and Urban Development Coordinating Council (HUDCC), through the General Appropriations Act for the FY 2015 intends to apply the sum of Php1,100,000.00 being the Approved Budget for the Contract (ABC) inclusive of local taxes, to payments under the contract for supply and delivery of one (1) unit motor vehicle with the minimum technical description:

" Any four-wheel utility vehicle, wagon type with not less four doors and engine displacement not exceeding 2500cc for diesel. Allowable options/accessories: AM/FM Stereo cassette/CD player/MP3, car air conditioning unit."

2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. The HUDCC now invites bids for the for supply and delivery of one (1) unit motor vehicle Delivery of the Goods is required within 15 days from receipt of Notice to Proceed (NTP) Bidders should have completed, within one (1) year from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
6. Interested bidders may obtain further information from HUDCC and inspect the Bidding Documents at the address given below during office hour from 8:00 A.M. to 5:00 P.M.
7. A complete set of Bidding Documents may be purchased by interested Bidders on 16 September 2015 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Php1,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

8. The HUDCC will hold a Pre-Bid Conference on 25 September 2015, at 10:00 A.M. at HUDCC Conference Room, 15th Floor, BDO Plaza, 8737 Paseo De Roxas, Makati City, which shall be open only to all interested parties who have purchased the Bidding Documents.

9. Bids must be delivered to the address below on or before 07 October 2015 at 10:00 AM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on 07 October 2015 at 11:00 A.M. at HUDCC Conference Room, 15th Floor, BDO Plaza, 8737 Paseo De Roxas, Makati City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

10. The HUDCC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
